- **19-** Troubleshooting-The successful agency will provide immediate maintenan ce support and assistance in the event of any disruption to the website. The manner and time frame for troubleshooting and the timelines for the resolut ion of the problems will be as follows:
- 20- Penalty-The Agency will provide system-generated reports in support of 99 .99% uptime on monthly basis on the last working day of every month.
